#### I. BACKGROUND AND JUSTIFICATIONS

The development of arbitration and mediation is a necessary objective to achieve in view of the economic boom that is predicted in Africa in the near future. This objective institutionally set and rigorously pursued in particular by the OHADA institutions, can only be achieved by building the capacities of stakeholders, the existence and effective functioning of credible arbitration and mediation institutions and the availability of qualified practitioners of African origin.

This objective of developing alternative dispute resolution methods is being confirmed and asserted in a context increasingly marked by the expansion of trade and investment relations in Africa, where disputes that may arise can be settled, in particular by arbitration or mediation. Without any doubt, the birth of the African Continental Free Trade Area (AfCFTA), designed by the Assembly of Heads of States and Governments of the African Union with the aim of strengthening economic relations between member States of the African Union (AU) and to promote the development of AU countries through the creation of a large integrated African market, will help accelerate the development of alternative dispute resolution methods. The level of implementation and ownership of these dispute resolution methods will surely influence the quality of the business climate and the economic emergence of Africa.

It is aware of these issues of great importance that the Regional Superior School of Magistracy (ERSUMA) of the Organization for the Harmonization in Africa of Business Law (OHADA), together with the Association for the Promotion of Arbitration in Africa (APAA), have agreed to devote the first day of activities of the OHADA Week that it organizes in Douala (Cameroon) with funding from the World Bank as part of the Business Climate Improvement Project (PACI) ), at the first edition of the African Day of Arbitration and Mediation. This first day of OHADA Week in Douala will be devoted to arbitration and mediation, which play an important role in the settlement of disputes between economic operators, investors and public entities in Africa.

This first edition of the African Arbitration and Mediation Day, which aims to strengthen African capacities in ADR law, comes as a prelude to two training sessions on ADR, of two days each, on the themes:

Theme 1: "Mastering The New Legal Framework On Arbitration In The OHADA Space";

Theme 2: "Mastering The New Legal Framework On Mediation In The OHADA Space".

The African Day of Arbitration and Mediation and the consecutive training sessions will in particular be an opportunity to revisit the legal and institutional framework of arbitration and mediation in Africa, to appreciate the practice of these alternative dispute settlement methods on the continent, and to equip arbitration and mediation actors with technical skills for the efficient conduct of proceedings.

The African Arbitration and Mediation Day is one of the activities of the OHADA Week in Douala, which are characterized by the main language chosen for the work. Indeed, as part of the implementation of multilingualism, the scope of which is essential in the appropriation of the law, the work of this day and the training sessions that will follow will be held mainly in English, with simultaneous translation into French.

#### I. AIMS

#### 1. GENERAL OBJECTIVE OF THE COLLOQUIUM

Provide guidance on good ADR practices for African arbitration and mediation centers; strengthen the capacities of African legal professionals, in order to prepare them to be competitive in the field of ADR at the international level.

## 2. SPECIFIC OBJECTIVES OF THE COLLOQUIUM

Specifically, it will be to:

- share the revisions made by the Organization for the Harmonization in Africa of Business Law (OHADA) on its texts relating to Arbitration and on the Uniform Act relating to Mediation;
- highlight the qualities of a good arbitrator and a good mediator;
- take stock of the process for including arbitration and mediation in contracts;
- equip participants on the implementation of the Mediation Agreement and / or the arbitration award;
- equip participants on the advantages of the use of mediation and arbitration in economic relations;
- build the capacities of participants on the execution of decisions resulting from these ADRs.

#### II. EXPECTED RESULTS

- African arbitration and mediation centers are sensitized and their skills highlighted;
- The participants are instructed on the innovations contained in the OHADA texts relating to Arbitration and Mediation;
- The difficulties encountered by African legal professionals on the control of ADRs are identified and the solutions are shared;
- Participants are equipped with the various aspects of predictability, management of the dispute itself and the monitoring of the procedure for executing decisions resulting from OHADA arbitration and mediation.

### III. TARGETS

This Day is organized for the benefit of economic operators and legal professionals, namely companies, magistrates, lawyers, bailiffs, notaries and other interested jurists.

# IV. PLACE AND DATE OF THE COLLOQUIUM

The Symposium is taking place in a hybrid fashion, face-to-face for some and virtually for other participants, on December 6, 2021.
